## **RESOLUTION NO. 2003-03**

A RESOLUTION OF THE VILLAGE OF WEBBERVILLE, TEXAS, CLARIFYING REFERENCES TO THE MUNICIPAL GOVERNING BODY AND VILLAGE OFFICERS AND ESTABLISHING PREFERRED VILLAGE TERMINOLOGY

- WHEREAS, on February 1, 2003, the community known as Webberville was duly incorporated as a municipality bearing the name "the Village of Webberville"; and
- WHEREAS, the governing body of the municipality finds that the terms "governing body," "city council," "board of aldermen," "city commission," "town council," "board of supervisors," and "village commission" are indistinguishable, synonymous terms referencing the governing body of a municipality with each term bearing no particular legal import; and
- WHEREAS, the governing body of the municipality finds it to be consistent with the terms of such incorporation and in the public interest to designate itself as the "Village Commission" and its members as "Village Commission Members;" and
- WHEREAS, Texas Local Government Code section 21.002 specifically states that the term "governing body" when applied to a municipality includes the "board of aldermen," "city commission" or "city council" when used by a state statute, municipal charter, or municipal ordinance; and

## NOW THEREFORE, BE IT HEREBY RESOLVED BY THE VILLAGE COMMISSION OF THE VILLAGE OF WEBBERVILLE, TEXAS, THAT:

- (1) The governing body of the Village of Webberville shall hereafter be designated as the "Village Commission."
- (2) To the extent practicable and consistent with state law, the terms "governing body," "city council," "board of aldermen," "city commission," "town council," "board of supervisors," and "village commission" when referencing the Village of Webberville, shall be read as applying to the Village Commission, the duly elected governing body of the Village of Webberville.
- (3) To the extent practicable and consistent with state law, the titles of any additional municipal offices created by law or appointed by the Village Commission shall include the term "Village" rather than "city" or "municipal" (e.g., "Village Clerk" and "Village Attorney").

- (4) This Resolution shall take effect immediately from and after the date of passage.
- (5) A quorum of the Village Commission was present at the meeting at which this Resolution was adopted. The meeting was open to the public and public notice of the time, place and purpose of said meeting was given as required by the Open Meetings Act, Chapter 551 of the Texas Government Code.
