

Please Note: PENAL CODE SECTION § 37.10. TAMPERING WITH GOVERNMENTAL RECORD.

Penal Code section 37.10 provides that a person commits an offense if he, among other things, "tampers with, intentionally destroys, conceals, removes, or otherwise impairs the verity, legibility, or availability of a governmental record." **An offense under Penal Code section § 37.10 ranges from a misdemeanor to a state jail felony.**

- a. Discuss amendment to Sec. 3.3.1 of the Village Zoning Ordinance to provide that in the Single-Family Residential District (SF) low-density detached, single-family residences shall also be allowed on any lot that was legally platted before the Village's incorporation; to schedule a subsequent meeting of the P&Z to review and discuss the proposed amendment, conduct a public hearing, and submit recommendations to the Village Commission as it may deem proper
- b. Discuss and possibly take necessary actions on violations of local ordinances by local property owners

4. Finance

- a. Discussion and possible action regarding an Ordinance amending the 2015-2016 budget and associated proposed amended budget

5. Public Works

- a. Open and review sealed bids for the maintenance and repairs of the Village streets and possibly approve
- b. Review Status of the Mowing of ROW's, Pothole Repair, Paving and other related items and take appropriate action and discuss the means of payment for road repair and/or improvements
- c. Review Status of the repairs and/or improvements needed to the Village Facilities and approve the appropriate funds for these and other repairs and/or improvements and consider possible options for a storage building

- a. Direct the Village Code Compliance/Enforcement Officer to issue notice(s) to ordinance violators

7. Public Meetings

- a. Discussion related to future meeting(s) and associated agenda items
