- a. Discuss and consider possible development within Webberville's ETJ (extra-territorial jurisdiction) and within our corporate limits.
- b. Receive a status update on the rezoning of the Las Monarcas subdivision.

6. Intergovernmental Affairs

- a. Discuss and possibly agree to an ILA (Inter-Local Agreement) with TCESD #12

7. Public Works

- a. Review the status and resurfacing of the Village Roads and ROW's (Right of Way's) and the associated equipment.
- b. Discuss and consider the acquisition of road/ROW maintenance equipment and associated shelter.
