2. Citizen Presentations

The Village Commission welcomes public comments at this point on items not specifically listed on the agenda. Speakers must sign up before the meeting begins. Speakers are limited to three (3) minutes each. The Commission cannot respond to matters not listed on the agenda until a future meeting.

3. Administrative

- a. Discuss and take appropriate action to create an event permit ordinance and the associated fees.

4. Community Affairs

- a. Acknowledge and recognize the 20-year anniversary of the incorporation of the Village of Webberville and discuss a possible celebration for this community milestone.
- b. Discuss possibly hosting a Village-wide garage/yard sale at the Village Hall property and plan accordingly.

5. Land Use

- a. Discuss the possibility of erecting a cell tower on the Village property and review proposal and lease agreement.
- b. Discuss and consider possible development within Webberville's ETJ (extra-territorial jurisdiction) and within our corporate limits.
- c. Review the PDD and associated documents related to the rezoning of the Las Monarcas subdivision.

6. Intergovernmental Affairs

- a. Discuss and possibly agree to a revised ILA (Inter-Local Agreement) with TCESD #12

7. Elections

- a. Discuss the May 6th, 2023 election to reauthorize the 1/4 of 1% Sales Tax for Roads and ROW's.

8. Facilities/Village Hall

- a. Discuss and take appropriate actions related to needed repairs/improvements to Village Buildings

9. Public Works

- a. Brief the Village Commission on the latest status of the Village Roads and ROW's (Right of Ways) and the associated equipment.
- b. Discuss the possible improvements to other Village roads.
