ORDINANCE No. 2016-03

BUDGET AMENDMENT

AN ORDINANCE OF THE VILLAGE OF WEBBERVILLE, TEXAS (“VILLAGE”), AMENDING ORDINANCE NO. 2015-06 AMENDING THE VILLAGE’S BUDGET FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2015 AND ENDING SEPTEMBER 30, 2016; PROVIDING THAT ALL PREVIOUS BUDGET ALLOCATIONS SHALL BE SAVED, EXCEPT AS AMENDED BY THIS ORDINANCE; PROVIDING FOR SEVERABILITY AND PUBLICATION, DECLARING AN EFFECTIVE DATE AND FINDING PROPER NOTICE AND MEETING.

WHEREAS, the Village is a Type-C, general-law municipality in the State of Texas and is required by Chapter 102 of the Texas Local Government Code to adopt a budget annually; and

WHEREAS, pursuant to Texas Local Government Code Section 51.001, the Village has general authority to adopt an ordinance or police regulation that is for the good government, peace or order of the Village and is necessary or proper for carrying out a power granted by law to the Village; and

WHEREAS, Texas Local Government Code Section 102.010 allows the governing body of the municipality to changes in the budget for municipal purposes; and

WHEREAS, the Village wishes to adopt a budget amendment for the 2015-2016 fiscal year.

NOW, THEREFORE, BE IT ORDAINED BY THE VILLAGE COMMISSION OF VILLAGE OF WEBBERVILLE, TEXAS AS FOLLOWS:

1. APPROVAL OF BUDGET AMENDMENT

The proposed budget amendment presented by the Mayor is hereby amended, approved, and adopted for the fiscal year 2015-2016, as set forth in Appendix 1 hereof.

2. CUMULATIVE CLAUSE

This Ordinance shall be cumulative of all provisions of ordinances of the Village of Webberville, Texas, except where the provisions of this Ordinance are in direct conflict with the provisions of such ordinances, in which event the conflicting provisions of such ordinances are hereby repealed.

3. SEVERABILITY CLAUSE

That if any section, subsection, paragraph, clause, phrase, or provision of this Ordinance shall be adjudged invalid or held unconstitutional, the same shall not affect the validity of this Ordinance as a whole or provision thereof, other than the part so decided to be invalid or unconstitutional.

4. SAVINGS CLAUSE

That all previous budget ordinances shall remain in full force and effect, save and except as amended by this Ordinance.

5. ENGROSSMENT & ENROLLMENT

The Village Secretary of the Village of Webberville is hereby directed to engross and enroll this Ordinance by copying the caption, publication clause, penalty clause, and effective date clause in the minutes of the Village Commission of the Village of Webberville and by filing this Ordinance in the ordinance records of the Village.

6. PUBLICATION CLAUSE

The Village Secretary of the Village of Webberville, Texas, is hereby directed to publish in the Official newspaper of the Village of Webberville, the caption, and effective date clause of this Ordinance as required by Section 52.011 of the Texas Local Government Code.

7. EFFECTIVE DATE

The necessity for making and approving a budget for the fiscal year, as required by the laws of the State of Texas, requires that this Ordinance shall take effect immediately from and after its passage, as the law in such case provides.

8. PROPER NOTICE & MEETING

It is hereby officially found and determined that the meeting at which this Ordinance was passed was open to the public, and that public notice of the time, place and purpose of said meeting was given as required by the Open Meetings Act, Texas Government Code, Chapter 551.


