ORDINANCE No. 2014- 02

BUDGET AMENDMENT

AN ORDINANCE OF THE VILLAGE OF WEBBERVILLE, TEXAS (“VILLAGE”) AMENDING THE CURRENT 2013-2014 FISCAL YEAR BUDGET; FINDING MUNICIPAL PURPOSES; AUTHORIZING EXPENDITURES; PROVIDING FOR A SEVERABILITY CLAUSE; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Village of Webberville’s budget for the current 2013-2014 fiscal year, October 1, 2013 through September 30, 2014, was adopted on September 27, 2013; and

WHEREAS, the Village Commission finds that the current fiscal budget must be amended to transfer \$2,500.00 from the Contingency Fund line to the Audit line item; and

WHEREAS, the Village Commission finds that the proposed Budget Amendment to the current fiscal budget is for legitimate municipal purposes, and thus is statutorily authorized by Texas Local Government Code section 102.010,

NOW, THEREFORE, BE IT ORDAINED by the Village Commission of the Village of Webberville:

1. FINDINGS OF FACT

The foregoing recitals are incorporated into this Ordinance by reference as findings of fact as if expressly set forth herein.

2. BUDGET IS AMENDED

The Village Commission of the Village of Webberville should and does hereby amend the 2013-2014 fiscal year budget by transferring \$2,500.00 from the ~~General Fund~~ into the Contingency Fund ~~line item~~ and allocating that amount to the Audit line item, under Contractual Services and

Other, and does hereby authorize the expenditure of public funds in accordance with the said budget, as hereby amended.

### 3. SEVERABILITY

Should any of the clauses, sentences, paragraphs, sections or parts of this Ordinance be deemed invalid, unconstitutional, or unenforceable by a court of law or administrative agency with jurisdiction over the matter, such action shall not be construed to affect any other valid portion of this Ordinance.

### 4. EFFECTIVE DATE

This Ordinance shall be effective immediately upon passage and publication as provided for by law.

### 5. PROPER NOTICE & MEETING

It is hereby officially found and determined that the meeting at which this Ordinance was passed was open to the public, and that public notice of the time, place and purpose of said meeting was given as required by the Open Meetings Act, Texas Government Code, Chapter 551. Notice was also provided as required by Chapter 52 of the Texas Local Government Code.

**PASSED AND APPROVED** this, the 13 day of May, 2014, by a vote of 2 (ayes) to 1 (nays) to 0 (abstentions) of the Village Commission of Webberville, Texas.
