

RESOLUTION NO. 2015-01

A RESOLUTION OF THE VILLAGE OF WEBBERVILLE, TEXAS CANVASSING AND CERTIFYING THE RESULTS OF THE GENERAL ELECTION HELD IN THE VILLAGE OF WEBBERVILLE ON TUESDAY, NOVEMBER 3, 2015, PERTAINING TO THE PROPOSITION OF “THE REAUTHORIZATION OF THE LOCAL SALES AND USE TAX IN THE VILLAGE OF WEBBERVILLE, TEXAS, AT THE RATE OF ONE-FOURTH (1/4) OF ONE (1) PERCENT TO CONTINUE PROVIDING REVENUE FOR THE MAINTENANCE AND REPAIR OF MUNICIPAL STREETS”.

WHEREAS, pursuant to the Texas Election Code Chapter 67, the Village Commission of the Village of Webberville, Texas (“Village”), convened this day, the ____ of November, 2015, for the purpose of canvassing the vote in the general election held on November 3, 2015.

NOW THEREFORE, BE IT RESOLVED BY THE VILLAGE COMMISSION OF THE VILLAGE OF WEBBERVILLE, TEXAS, THAT:

Section 1. Canvass of Election Results.

- (a) There came to be considered the returns of the general election held on November 3, 2015, for the purpose of determining whether to reauthorize the Village Commission to levy and collect a sales and use tax within the Village under provisions of Chapter 327, as amended, Texas Tax Code (“Act”) for the maintenance and repair of municipal streets; and it appearing from said returns, duly and legally made, that the said proposition (“Proposition”) in said election received the following votes:

- (b) It is found that the total number of votes cast for and against was Twenty-Six (26) with the proposition being approved by Nineteen (19) vote for and Seven (7) votes against.
- (c) It is further found, determined and declared by the Village Commission that that the election was duly ordered and called; that proper notice of the election was given in accordance with

law, that proper election officers were duly appointed prior to the election, that the election was held in accordance with the applicable laws; that returns of the results of the election have been made and delivered, and that the Village Commission has canvassed the returns, all in accordance with the law and the resolution calling the election, and that that the proposition for the reauthorization of the local sales and use tax in the Village Commission, Texas, at the rate of one-fourth of one percent to provide revenue for maintenance and repair of municipal streets was approved on November 3, 2015.

Section Two. Copy of This Resolution to the Texas Comptroller of Public Accounts.



Section Three. Open Meetings.


